Should this be a natural person, the purchaser is considered to be the sole user of the sound recordings, and consequently, the sole holder of this usage license.

Should the purchaser be a legal person, this license shall cover all of this legal person's members, associates, employees or staff, in accordance with conditions established in paragraph 4 of this license. These people shall be considered, for the purposes of this license, as users and holders of this license, and shall be irrefragably presumed to have made themselves aware of the contents of the license and to have agreed, without reservations, to its terms.

#### 2 - Terms and conditions

- Provide remote access to unsynchronized Recordings to any location remote from licensed User address.

# 6 - Term of agreement

It shall be terminated in the event the User does not comply with the terms and conditions hereof.
